

Chairman's Report



Uma Shanker Chairman, CE Midlands

May I start by saying just how excited and honoured I am to be part of the CE Midlands team during this very interesting and no doubt challenging period...I look forward to working closely with the team, and will count on Mark Wakeford and the wider team's support. Mark, thank you for a sterling job so far, and I really appreciate you staying on to support. Thank you all so much for welcoming me in the way you have done.

CE is an organisation with great heritage and tremendous potential; "by the body, for the body", as Andrew Carpenter put it recently at the Black Country launch event attended by Andy Street, Mayor of the West Midlands.

Let's just take a moment to reflect on this region, the West Midlands, and then touch on our profession and some wider external influences, be they social, economic or, dare I say, political factors that will impact our industry over the coming months and years.



First, Our Region

Our region is changing...rapidly fuelled by infrastructure projects such as HS2, for whom I happen to work, West Midlands Metro and, of course, Network Rail station upgrades that improve accessibility and connectivity, as well as major events such as the 2022 Commonwealth Games and Coventry 2021 City of Culture.

If you want to know what this sort of investment and events do to a region, simply look at the Birmingham skyline and count the cranes, or the number of Costas, Starbucks, bars and restaurants that have opened recently.

- We have the fastest growing younger population in the UK
- House prices are rising faster than anywhere else
- Inward investment is up
- More and more HQs are moving to Birmingham – Deutsche Bank, KPMG and PWC to name a few recent ones

This really is an exciting time for the West Midlands and, with its interconnectivity to the rest of the country, we can influence and shape the national agenda like no other region.

Second, Our Industry

Just over a year ago, I was involved in what I can only describe as a once in a 100 year experience. Everyone sort of expected it and we sort of planned for it, but, when it happened, it was a real shock. I am, of course, talking about Carillion — it's not every day that the biggest player in your industry goes bust. In fact, I worked closely with a number of colleagues, and we must not forget the impact these things have on people...sometimes, across 3 generations.

And then, of course, there is Grenfell. That happened in the wealthiest local authority in the UK – Kensington and Chelsea – and, through the Hackitt report, is asking some fundamental questions about our approach and culture to quality and compliance.

CE has a huge role to play in shaping and influencing our industry, not just to survive, but also to embrace change, collaborate and thrive.

Our industry is starting to adopt artificial intelligence – 'smart construction' through BIM, off-site, lean and collaborative procurement... but not fast enough. We are only just starting to really embrace wider initiatives on health, mental health and wellbeing, diversity, sustainability, skills, education and employment.

Third, Our Talent Pool and Knowledge Base

We have a tremendous talent pool working out of some world class institutions based in the Midlands as clients, consultants, contractors and in colleges and universities.

With support and engagement from this breadth and depth of knowledge and talent in our region, we really can play an important role.

In fact, you only have to look at the quality of the entries in the Celebrating Construction Awards to know that!
Our distinguished judges had a real hard time choosing the winners!



Using the already tried and tested formula that has been successful within CESW for five years we have been able to quickly put in place a strong **Board, influential Leadership Council and seven active Thought Leadership Forums** together with working closely alongside existing clubs in the **East Midlands, Shropshire and** Hereford & Worcestershire. In addition, we have re-launched clubs in the Black Country and Coventry & Warwickshire (FoRCE). Our aim in our second year is to re-launch a strong club in Birmingham and establish links in Staffordshire.

I would like to pay tribute to Mark Wakeford, previously chair of the Built Environment Hub and now Vice Chair of CE Midlands, for his knowledge and good humour as we've made the transition from BEH to CEM. We have a very strong board of fourteen people taken from across the East & West Midlands construction supply chain that is providing expert leadership in our pursuit of 'best practice' and our desire to improve the performance of the sector. I would especially like to thank Keith Blizzard, Company Secretary, and Tom Woodhead, Treasurer, for joining Mark and myself as named directors at Companies House.

With the Board providing the direction, as originally set out by the ground-breaking Egan and Latham reports of the 1990s and more recently brought to light by the Farmer and Hackitt Reports, our Leadership Council, so expertly chaired by Sean Bowles of Morgan Sindall, is providing the detail required to implement the 'best practice' across the Midlands. He has a team of 50+ people made up of CE national members, Industry Bodies & Stakeholders, Universities & Colleges, Club & Forum Chairs and representatives from CE Regional Members across the supply chain. This is the group that provides the total integration of the supply chain and epitomises the core principle of collaboration within Constructing Excellence.

The Leadership Council convened for the first time this year in April, under the **Chairmanship of Sean Bowles.** The session took place at the **Manufacturing Technology Centre in Ansty and delegates** were treated to a tour of the facility, illustrating some of the latest advances in automation for the manufacture and assembly of buildings, and also how a connected digital environment can translate into mobile manufacturing through their 'Factory in Box' development.

We also benefited greatly from the presentation made by Keith Waller, Programme Director from the Construction Innovation Hub, illustrating the scale of transformation needed in the sector and how this can be met through manufacturing technologies, and digital ways of working to improve productivity and asset performance – themes that are central to the Construction Sector Deal.

It was acknowledged that many of us are currently subject to the echoes of uncertainty, and so the UK Economic Outlook briefing from Kush Purewal, Partner at KPMG, was very well received and left the group feeling positive about the prospects for the economy and the opportunities that lie ahead in the built environment.



Constructing Staffordshire Club Staffordshire Excellence Forum

The Herefordshire and Worcestershire Constructing Excellence Club (HAWCE) has had another busy 12 months with seminars generally every other month to promote best practice and continuing development. Some of the highlights include the following...

Lessons to be learnt from Grenfell – last summer we had an event focussed on this difficult topic with two great speakers. First, we had David Payton from the West Midlands Fire Service giving a fire fighter's perspective of dealing with fires in high rise buildings and how the design and layout of buildings is so critical. It was both fascinating and frightening to hear about how fire fighters have to tackle such incidents.

Our second speaker was Terry Stocks of SNC Lavalin – Faithful & Gould, who was appointed by the Ministry of Housing, Communities and Local Government to put in place a team that could immediately support the response surrounding affected buildings and building owners, post the Grenfell Tower fire. Terry talked about how we must use the Grenfell disaster as a catalyst for change in the way we specify, design, deliver, operate and manage buildings.

In September we had a more local based event looking at a project which has been promised for many years and at last is now taking shape which will greatly increase rail connectivity for Worcestershire and the surrounding areas, namely the construction of the new Worcestershire Parkway railway station. We heard from Samantha Uren, Engineering Director at SLC Rail, and she explained some of the challenges and opportunities which this project had given rise to. Fingers crossed, the new station will be completed by the end of 2019 and this will improve access to the north and the south west.

The use of Building Information Modelling and other technologies has been a key theme for HAWCE over the last few years. In April we heard from Kier Group on the steps they are taking to embrace technology on construction sites and we heard from Thomas Nhachi who is leading BIM implementation in Kier Central. Through the BIM process, Thomas is a leading influencer on collaborative working environments amongst project stakeholders, based on lean and accurate design managed efficiently through the project life cycle.

We also heard from Jason Whittall, an award winning BIM specialist at One Creative Environments (who is also a HAWCE committee member) on the practical applications of BIM. He demonstrated how virtual mock-ups can be cheaper, faster and more accurate than physical prototypes. He also shared the outcome of an R&D project that he undertook with BESA to allow useable planned maintenance schedules to be delivered directly from a model, in order to provide a valuable hand over for clients, almost as a bi-product of the BIM process.

In terms of products, we heard from Andy Goodwin, the Managing Director of B&K Structures, about the use of cross laminated timber (CLT), its advantages and disadvantages, and where it is appropriate to use it in construction. We also had a presentation from Trudi Sully, Associate Director for Construction and Infrastructure, of the Manufacturing Technology Centre, Coventry, on how manufacturing technology is set to transform how we procure, design, supply and install buildings and other structures in the not too distant future.

Environmental issues are vitally important and following up from presentations in previous years on ecological issues, we had an entertaining and informative presentation from Howard Gray of Green Blue Urban on sustainable urban drainage and particularly the correct use of tree planting in urban environments which can greatly contribute towards not only mitigating flood risk, but also the appearance of our urban landscapes and even mental wellbeing. He highlighted the way that trees were frequently planted as part of building projects was wholly inadequate and led to many trees not thriving or even dying away. He highlighted the need for early involvement of urban landscapers in construction projects and how to properly implement and design tree planting schemes.

Looking forward, our next event is a joint one with the CIOB involving a tour of a new cyber security centre being constructed by the Worcestershire headquartered contractor, Speller Metcalfe. We hope to do further joint events with the CIOB going forward and have previously done joints events with other bodies such as RIBA.

We also plan to have a presentation by the Environment Agency on flood risk management, an increasingly topical event with climate change and a matter of considerable local interest with the River Severn flowing through Worcester and other county towns.

Finally, we are also planning a presentation on the 'Get it Right' initiative, linking up with committee member Steve Green of Bouygues who chairs the Quality and Compliance Forum for Midlands CE. Improving the quality of construction is clearly a key issue for the industry to address.



Martin Brownsill Chair. CSE Forum

The Constructing Staffordshire Excellence Forum (or CSE for short) holds events 3 or 4 times per year at our adopted home of Stoke-on-Trent College. The College provides a venue and administration support to the forum which helps us provide free events to our growing membership.

Our Spring 2019 event majored on 'New Trends in Residential Development'. Stoke-on-Trent City Council's Assistant Director of Private Sector Housing, Development and Regeneration's presentation stimulated lively discussion on the long decline and potential rise in Local Authority housing stock as a result of:

- affordable housing initiatives funded by private institutions;
- the lifting of the LA borrowing cap for housing;
- and LA investment in PRS housing which the City of Stoke is leading the way in.

The event was concluded with a legal view of 'Dealing with Defects' presented by Myers & Co solicitors.

Our Summer event, titled 'Unlocking Development in Staffordshire' focussed on some of the common (if not entirely unique) challenges associated with developing in Staffordshire. Whether those challenges are associated with geology, previous land uses or low sales/rental values it can sometimes be difficult to get projects away. We had a double headed presentation from: Hydrock on the risks and opportunities associated with brownfield sites; and Stoke Council on Investment, Planning & Regeneration initiatives to promote development.

Our Autumn event (soon to be announced) will include a detailed examination of North Staffordshire's exciting Green Energy and District Heating Network currently at pilot project stage.

We also intend to engage in the Local Industrial Strategy and make our members fully aware of CITB funding opportunities.

Our officers (below), and our wider dedicated committee, are passionate about the generation of growth in the Staffordshire construction industry and assisting the Staffordshire construction community respond to new business opportunities.

This year

Since the first meeting of the CCG attendance has grown by 80%, we have had presentations by:

Steve Ward of Gilbert & Goode Construction, delivering a thought-provoking presentation on ISO 18404: A Model for Lean Transformation in the Construction Sector.

Daniel Musselwhite of Beyond Consulting who shared his expertise on delay analysis, contract dispute resolution and how best to avoid getting in that position.

Jonathan Skipp and Ben Atkinson of Greenacre recruitment who presented the current position of the market in relation to skillsets, availability and routes to successfully attracting/appointing the right staff.

Our terms of reference have been agreed, reviewed, re-prioritised and are set out below, hopefully to tweak your interest, only you can decide if we have got our priorities right, only you can change those priorities by getting involved:

- a) Getting the brief right
- b) Understanding the needs of the supply chain (especially with regards to offsite)
- c) Identifying 'what is' a Project Manager
- d) Digitalisation (BIM) requirements
- $e) \ \textbf{Offsite Construction}$
- f) Quality Management/Compliance
- g) Explain the meaning of 'behavioural change incorporating procurement & risk'
- h) Becoming an 'informed client'
- i) Provide a 'learning and sharing' network to include, in the first instance, best practice procurement initiatives
- j) Support client members through the change agenda to achieve excellence
- k) Low energy and sustainability
- l) Space and design standards
- m) CDM compliance

Those in **bold type** will be the immediate priorities to drive the CCG forward.

Our terms of reference (we believe) are the building blocks of change:

- a) We acknowledge the need for change within the UK construction industry.
- b) We recognise the responsibility that clients hold to deliver that change.
- c) We identify Constructing Excellence principles as the direction of travel we need to take to achieve the necessary change.
- d) We seek out best practice in the areas of change we identify as required.
- e) We demonstrate and communicate said best practice.
- f) We use that knowledge to influence change and support our supply chains.

Willmott Dixon have kindly agreed to host our first meeting of the new year where will have the opportunity to explore their BIM cave solution for new build and refurbishment works, Catherine Manning has also accepted an invite to deliver a presentation on Social Value and sustainability. These are two great opportunities to witness innovation at work and understand the culture change journey the construction industry is pursuing.

A current CCG member, Natalie Cropp is pulling a case study together in conjunction with a colleague in skills development based on previous experiences that won the People Development Award at the Celebrating Construction Awards

We have members who are delivering modular construction faster than traditional construction, to a high standard delivering EPC A rated new homes. This is an area that is stimulating and exciting we will be looking to learn from in the next year.

We are planning to complete an exercise in terms of what 'Becoming an Informed client' means in the eyes of the client, contractor, supply chain and end user.

With the construction industry being recognised as slow to change, working in silos, reluctance to 'fix what's not broken' and 'do what we have always done' mainly in an insular uncollaborative fashion, it makes you wonder how the disparate project delivery of such complexity produces anything. Unless of course behind the above picture there is a determined drive to the change agenda that will and is improving industry performance to produce an outstanding built environment.

Quality & Compliance



Steve GreenChair, Quality and Compliance Forum

When Andrew asked the **Leadership Council which Thought Leadership Groups** we should have in CE Midlands. I was adamant that we needed a Quality & Compliance Group. We have all seen construction in the spotlight of the press for all the wrong reasons – Edinburgh **Schools, Grenfell and defects** in new build housing. However, whilst I have a personal passion to drive improvement in this area, I had not really thought through, how we were going to rally enough support to make the Q&C Thought Leadership **Group viable! All too often the** industry bemoans the quality we produce but then don't want to get involved in trying to improve

This Year

I am pleased to say that in the case of CE Midlands there was no need for concern. We now have 16 members on board with a healthy balance of Clients, Consultants and Contractors. We do have a sad absence of Supply Chain Partners and that will be one of our recruitment focuses for the coming 12 months.

Although a couple of 'exploratory' meetings were held in 2018, the full group met for the first time in February 2019 and rapidly agreed our purpose which was to;

- Capture best practice in delivering Construction Quality and to avoid reinventing any new wheels!
- Take a holistic view of Quality through design, manufacture, installation, testing and commissioning to the handover of the built asset.
- Actively encourage collaboration across all parties involved in a project, to develop a mutual understanding of how we can collectively help to deliver a quality end product.

We held our first ever event in June of this year, which was a little ambitious, given the fledgling state of the group. However, we attracted over 40 delegates including organisations such as Balfour Beatty, Bouygues UK, MACE, Midland Metro Alliance, Morgan Sindall, Wates, Waterloo Housing Group, WM Housing and Wolverhampton City Council.

The event was built around a number of the Groups Objectives for the year, so included presentations on;

- The Clients response to Hackett
- An Introduction to the Get It Right Initiative
- Chartered Quality Institute Consig work on avoiding recurring defects
- The use of digital tools to manage on site quality

The event was well received by all that attended, particularly the introduction to the Get It Right Initiative delivered by Emma McNab. Emma's interactive session included a 5 minute slot where the audience turned to the person next to them to share an error or defect that had caused them particular 'pain'. Emma did very well to return the room to order after the 5 minutes as it appeared as if many could have gone on talking about the issues for the rest of the day. This is exactly the open and honest sharing of knowledge, that the group is encouraging.

The Future

Having seen the success of the 'defects confessional', we agreed at our last meeting that we would have a similar agenda item at all our future Q&CTLG meetings. Operating strictly under Chatham House rules, all attendees are to give a brief overview of an error/defect they have encountered, its implications and how it is being prevented from occurring in the future. We then look to how we capture this and share it with the wider industry.

Following on from the CQI Consig work on common defects, we have now agreed that the Contractors in the group will circulate their quality management (ITP, WIR etc.) forms currently used for Fire Stopping, as an example of a high risk trade. The group will then investigate the opportunity to standardise the format of the forms for this trade, with a view to creating a 'best of' format that could be used throughout the industry. This consistency of format would be a major step forward in establishing a clear understanding of the key quality deliverables on a project and how they are to be managed.

The group also hope to issue their first publication later in the year, which is a guide to using digital tools to manage quality on site. There was a lot of interest in the Field View software that was demonstrated at the June event and this guide will support those new to this approach, in making the right choice on the software they select.

Our last objective is to understand, define and then promote the business benefits of clearly defining Quality to all parties concerned. In the last meeting we brain stormed the various ways in which we do currently define Quality and the next six months will be spent on promoting this aspect and the business benefits of doing it well.

Finally, at out last meeting Deborah Lawley shared a strapline from a previous employer that we all liked, so felt obliged to share it here 'Remember, today's quality is tomorrow's safety'.

The Forum will be working towards our first publication later this year entitled 'Route Map to Zero Carbon' which will be a guide to help simplify approaches and practices both on and offsite to implement zero carbon. This will be undertaken with a key sponsor and will be in parallel to the 'Major Contractors Group' of the NFB who are currently researching a similar publication focused on Contractors.

We will be undertaking to reach out and connect with the wider construction industry across the Midlands to ensure our Discussions, Events and 'Innovathons' provide a world class line up of keynotes speakers, panel discussions, networking sessions, live interviews, innovation spotlights and much more.

Finally, it could be said that we stand at an industrial revolution in construction. Automation and data exchange — the fourth industry revolution — has transformed other industries such as retail and manufacturing. New technologies are revolutionising the speed and efficiency of construction projects. The Forum will be part of this journey of innovation towards a sustainable industrial transformation.


Marketing & Communications
